If your clinic is ready to evaluate remote monitoring partners, below is a recommended process to follow to ensure the partner you select meets your clinic's needs.

1.Engage Your Team

Assemble a cross-functional team from your clinic who should be involved in the decision-making process. See the last page of this guide for a recommended list of participants.

2. Identify Your Needs

Discuss the biggest challenges in your remote monitoring program and what you're looking to solve. Align on the most pressing needs and create a list of vendor requirements, rating each vendor's capabilities.

3. Vendor Research

Research different vendor options to see which platforms offer the solutions that best meet your needs.

4. Solution Demos

After reviewing RFP responses, schedule product demonstrations with vendors and your team to see each solution in action. Ask follow-up questions and get specific input on how your teams would work together.

5. Make Your Decision

Review your evaluations and feedback against the requirements you identified earlier and make your selection based on those results.



Making Your Decision
